



## Tennessee Fire Service Coalition 2021 Comprehensive Bill Report

### SB5/HB365 PUBLIC EMPLOYEES: Volunteer firefighters to receive commission for completing training.

*Sponsors:* Sen. Yager, Ken , Rep. Russell, Lowell  
*Summary:* Allows a volunteer firefighter to receive \$800 from the commission on firefighting personnel standards and education for completing 40 hours of training annually.  
*Fiscal Note:* (Dated February 12, 2021) Increase State Expenditures - \$5,100,800/FY21-22 and Subsequent Years  
*Senate Status:* 01/13/21 - Referred to Senate State & Local Government Committee.  
*House Status:* 02/23/21 - Taken off notice in House Cities & Counties Subcommittee.

### SB15/HB7 HEALTH CARE: Powers of county mayor during a county-wide health emergency.

*Sponsors:* Sen. Bell, Mike , Rep. Zachary, Jason  
*Summary:* Specifies that the county mayor has the authority to establish and implement health policies that affect the entire county during a county-wide health emergency. Directs the county health director, health officer, and board of health to provide advice to the mayor to develop the policies. Applies only in Shelby, Davidson, Knox, Hamilton, Sullivan, and Madison counties.  
*Amendment Summary:* Senate Health & Welfare Committee amendment 1 (006610) deletes and rewrites all language after the enacting clause such that the substantive changes: (1) establish statewide applicability; (2) establish county boards of health act solely in advisory roles to county mayors during public health emergencies, as determined by the county mayor; and (3) remove primacy prescribed to regulations of county boards of health over certain local ordinances. House amendment 1 (003975) deletes and rewrites all language after the enacting clause such that the substantive changes: (1) establish statewide applicability; and (2) remove primacy prescribed to regulations of county boards of health over certain local ordinances. House amendment 1 to 1 (004445) amends provisions of Amendment 003975 to establish county boards of health act solely in advisory roles to county mayors during public health emergencies, as determined by the county mayor.

*Senate Status:* 04/08/21 - Re-referred to Senate Calendar Committee.  
*House Status:* 03/08/21 - House passed with amendment 1 to 1 (004445) and amendment 1 (003975).

### SB19/HB864 CRIMINAL LAW: Assault against a first responder includes nurses.

*Sponsors:* Sen. Gilmore, Brenda , Rep. Chism, Jesse  
*Summary:* Adds nurses to the assault against a first responder who is discharging or attempting to discharge official duties statute.  
*Fiscal Note:* (Dated January 26, 2021) NOT SIGNIFICANT  
*Senate Status:* 03/01/21 - Senate passed.  
*House Status:* 05/03/21 - House passed.  
*Executive Status:* 05/21/21 - Enacted as Public Chapter 0458 effective July 1, 2021.

### SB29/HB105 LOCAL GOVERNMENT: Residency requirements as condition of employment for first responder.

*Sponsors:* Sen. Kelsey, Brian , Rep. Moon, Jerome  
*Summary:* Prohibits a local government from having residency requirements as a condition of employment for a first responder. Broadly captioned.  
*Amendment Summary:* Senate amendment 1 (003761) replaces this bill's prohibition against local governments establishing residency requirements for first responders with a prohibition against local governments dismissing, disciplining, fining, or penalizing a first responder employed by a local government, or denying employment to a person applying to be a first responder, based on where the first responder or applicant resides. This amendment modifies this bill's definition of "first responders" to include dispatchers of law enforcement, fire, and emergency medical service departments and exclude department chiefs and heads. This amendment adds that this bill will not affect a local agencies' policies that require responses by employees who, based upon their assignment, are required to respond to an emergency or call out within a specific time period. Senate amendment 2 (004082) adds to this bill's preamble and exempts Hamilton County from the prohibition against imposing residency requirements on first responders employed by local government entities.  
*Fiscal Note:* (Dated January 7, 2021) NOT SIGNIFICANT  
*Senate Status:* 03/04/21 - Senate passed with amendment 1 (003761) and amendment 2 (004082).  
*House Status:* 03/16/21 - House Cities & Counties Subcommittee deferred to summer study.

### SB163/HB167 JUDICIARY: Confidentiality - communications during crisis intervention.

*Sponsors:* Sen. Pody, Mark , Rep. Moody, Debra  
*Summary:* Adds communications between a peer supporter providing critical incident stress management intervention and a law enforcement officer, firefighter, or emergency medical services personnel to those communications that are considered confidential and for which a person cannot be called to testify or otherwise divulge.  
*Amendment Summary:* Senate amendment 1 (005560) rewrites this bill and redefines "crisis intervention" and "crisis response services" for purposes of the privileged communications described above in the bill summary. Present law defines "crisis response services" as a session at which crisis response services are rendered by a critical incident stress management team member or leader during or after a crisis or disaster. This bill redefines the term to include such sessions rendered prior to a crisis or disaster. Similarly, present law defines "crisis response services" as consultation, risk assessment, referral and crisis intervention services provided by a critical incident stress management team to individuals affected by crisis or disaster. This amendment redefines the term to include prevention interventions.  
*Fiscal Note:* (Dated January 13, 2021) NOT SIGNIFICANT  
*Senate Status:* 04/07/21 - Senate passed with amendment 1 (005560).  
*House Status:* 04/14/21 - House passed.  
*Executive Status:* 05/03/21 - Enacted as Public Chapter 0245 effective July 1, 2021.

### SB263/HB1497 RETAIL TRADE: Certification as an outdoor fireworks display operator.

*Sponsors:* Sen. Niceley, Frank , Rep. Towns Jr., Joe  
*Summary:* Requires fire marshal to establish process for certification as an outdoor fireworks display operator, proximate pyrotechnic display operator, or flame effect display operator.  
*Fiscal Note:* (Dated January 21, 2021) Decrease State Revenue Net Impact - \$6,700/FY21-22 and Subsequent Years/ State Fire Marshal's Office  
*Senate Status:* 03/22/21 - Senate passed.  
*House Status:* 04/27/21 - House passed.  
*Executive Status:* 05/17/21 - Enacted as Public Chapter 0435 effective May 13, 2021.

### SB275/HB369 PROFESSIONS & LICENSURE: Contracting performed by unlicensed persons.

*Sponsors:* Sen. Rose, Paul , Rep. Williams, Ryan  
*Summary:* Sets requirements for exemptions from contractor licensing requirements for real property owners who intend to construct a residential building on that real property. Requires notice of construction made to the board for licensing contractors and the register of deeds.  
*Fiscal Note:* (Dated January 23, 2021) NOT SIGNIFICANT  
*Senate Status:* 04/12/21 - Re-referred to Senate Calendar Committee.  
*House Status:* 03/29/21 - House passed.

**SB358/HB1074 CRIMINAL LAW: Penalty for assault of a first responder.**

*Sponsors:* Sen. Hensley, Joey , Rep. Kumar, Sabi  
*Summary:* Increases the penalty for assault of a first responder from a Class A misdemeanor to a Class E felony.  
*Amendment:* Senate Judiciary Committee amendment 1, House amendment 1 (005080) deletes and replaces language in the original bill. Adds healthcare provider to the definition of first responder as it applies to the offenses of assault or aggravated assault against a first responder. Defines healthcare provider as healthcare professionals licensed, registered, certified, or permitted pursuant to Title 63 or Title 68 and regulated under the authority of either the Department of Health (DOH) or any agency, board, council, or committee attached to the DOH.  
*Fiscal Note:* (Dated February 4, 2021) Increase State Expenditures \$7,370,500 Incarceration\* Decrease Local Expenditures \$611,100/FY21-22 and Subsequent Years  
*Senate Status:* 04/07/21 - Senate Judiciary Committee deferred to first calendar of 2022 after adopting amendment 1 (005080).  
*House Status:* 04/14/21 - House passed with amendment 1 (005080).

**SB480/HB695 CRIMINAL LAW: Officer Kenny Moats Assault Act.**

*Sponsors:* Sen. Haile, Ferrell , Rep. Russell, Lowell  
*Summary:* Increases the punishment for assault committed against a first responder from a Class A misdemeanor to a Class E felony.  
*Fiscal Note:* (Dated February 9, 2021) Increase State Expenditures \$7,370,500 Incarceration\* Decrease Local Expenditures \$611,100/FY21-22 and Subsequent Years  
*Senate Status:* 02/11/21 - Referred to Senate Judiciary Committee.  
*House Status:* 02/20/21 - Referred to House Criminal Justice Subcommittee.

**SB525/HB949 PROPERTY & HOUSING: Carbon monoxide alarms required for one and two-family rental units.**

*Sponsors:* Sen. Briggs, Richard , Rep. Littleton, Mary  
*Summary:* Requires landlords of one or two-family rental units with a fossil-fuel burning heater or appliance, a fireplace, or other feature, fixture, or element that emits carbon monoxide to install carbon monoxide alarms 10 feet from every bedroom. Makes it unlawful for anyone to tamper with carbon monoxide alarms and adds the expectation of tenet to examine alarms to ensure they are in working order and notify the unit owner if they are not. Requires smoke alarms with tamper-resistant batteries that operate for a minimum of 10 years to replace existing smoke alarms in all in one-family, two-family, and multi-family residential dwellings constructed before July 1, 2021, if existing smoke alarms are more than 10 years old, is expired, is not working, or if tenants residing in the unit change.  
*Fiscal Note:* (Dated March 12, 2021) NOT SIGNIFICANT  
*Senate Status:* 04/06/21 - Taken off notice in Senate Commerce & Labor Committee.  
*House Status:* 03/31/21 - House Business & Utilities Subcommittee deferred to the first calendar of 2022.

**SB539/HB657 PUBLIC FINANCE: Bonds and notes issued by local governments.**

*Sponsors:* Sen. Watson, Bo , Rep. Baum, Charlie  
*Summary:* Requires revenue anticipation notes have approval by the comptroller of the treasury or the comptroller's designee. Establishes renewal timeline for unpaid notes. Makes exemptions for FHA loans or any other direct lending department of the government of the United States. Makes other revisions to provisions governing bonds and notes issued by local governments (20 pp.).  
*Fiscal Note:* (Dated February 26, 2021) Other Fiscal Impact Due to multiple unknown factors a precise recurring decrease in local government expenditures cannot reasonably be determined.  
*Senate Status:* 03/29/21 - Senate passed.  
*House Status:* 03/29/21 - House passed.  
*Executive Status:* 04/16/21 - Enacted as Public Chapter 0128 effective April 13, 2021.

**SB631/HB749 CONSTRUCTION: Conflict between a city and county regarding a building code or fire code issue.**

*Sponsors:* Sen. Bell, Mike , Rep. Boyd, Clark  
*Summary:* Increases, from ten working days to 12 working days, the time within which, after receipt of a written appeal, the state fire marshal's office must provide a decision in cases of conflict between a city and county regarding a building or fire code issue. Broadly captioned.  
*Amendment:* Senate Commerce & Labor Committee amendment 1 (006726) deletes all language after the enacting clause. Effective September 1, 2021, prevents the State Fire Marshal's Office (SFMO) from discriminating against or favoring particular construction materials or techniques in building construction standards. Effective upon becoming a law, authorizes a local government to adopt a regulation, code, or ordinance pertaining to construction materials by ordinance or resolution for one and two-family dwellings. House amendment 1 (007127) rewrites this bill and revises present law provisions governing statewide building construction safety standards. Present law requires the state fire marshal to promulgate rules establishing minimum statewide building construction safety standards. The standards must be designed to afford a reasonable degree of safety to life and property from fire and hazards incident to the design, construction, alteration and repair of buildings or structures. Present law mandates that the standards must not discriminate against or in favor of particular construction materials or techniques. This amendment specifies that the prohibition regarding "techniques" applies to "construction techniques" and: (1) Authorizes a local government to adopt a regulation or code, pertaining to construction materials by ordinance or resolution, as appropriate, by majority vote. If passage of the ordinance or resolution requires two readings, then the requirement may only be adopted after reading it in open session of the legislative body at meetings on two different days. If passage of the ordinance or resolution requires three readings, then the last two readings must occur on two different days. A proposed requirement pertaining to construction materials must be a separate item on the agenda and include, in bold type and all caps, the following statement in the meeting notice: THE PROPOSED ORDINANCE REQUIRES CERTAIN MATERIALS TO BE RESTRICTED IN THE CONSTRUCTION OF BUILDINGS; (2) Requires that consideration of a requirement pertaining to construction materials be by separate vote. If the requirement is to be part of a general ordinance or resolution, then the requirement pertaining to construction materials must be severable from the rest of the ordinance or resolution, and voted on separately; (3) Provides that if a local government seeks to modify a regulation, code, or ordinance adopted pursuant to this amendment, then the local government must make the modification in the same manner as required to adopt a requirement; (4) Mandates that a regulation, ordinance, or code adopted pursuant to this amendment must not prohibit a particular construction material that is approved by a national building code or the state fire marshal; (5) Requires that a regulation, ordinance, or code adopted pursuant to this amendment allow for the consideration of waivers of the adopted regulation, ordinance, or code pertaining to construction materials, in whole or in part, during the development approval process; (6) Specifies that denial of a waiver related to a regulation, ordinance, or code referenced in item (5) will not constitute a prohibition under item (4); and (7) Provides that, except to the extent local law conflicts with this amendment, this amendment neither grants nor removes local governmental authority to promulgate provisions under home rule charters, private acts, or general state law. The provisions of this amendment regarding a local government's adoption of a regulation or code, pertaining to construction materials do not limit the professional judgment of a licensed design professional with respect to electrical, mechanical, or plumbing standards. For purposes of local government adoption of a regulation, code, or ordinance relating to construction materials, this bill as amended will take effect upon becoming law. For all other purposes, this bill as amended will take effect September 1, 2021.

**SB655/HB612 PUBLIC EMPLOYEES: Length of service award programs.**

*Sponsors:* Sen. Bowling, Janice , Rep. Gant, Ron  
*Summary:* Authorizes the state treasurer to establish a length of service award program for eligible employers to participate in a deferred compensation plan for bona fide volunteers. Specifies that the commissioner of finance and administration, the chairs of the finance, ways and means committees of the senate and the house, and the state treasurer shall serve as trustees for the length of service award program if established.  
*Fiscal Note:* (Dated February 24, 2021) Other Fiscal Impact Due to the LOSAP being contingent on multiple unknown factors, and the willingness or capability of eligible employers to fund such a plan, the fiscal impact is estimated to be undeterminable at this time. However, this legislation may result in a permissive increase in local expenditures should local governments opt in to such program. Any net fiscal impact on state government is considered not significant.  
*Senate Status:* 03/15/21 - Senate passed.  
*House Status:* 05/04/21 - House passed.

Executive Status: 05/17/21 - Sent to governor.

**SB778/HB772 PUBLIC EMPLOYEES: Payments to volunteer firefighters for completing an in-service training course.**

Sponsors: Sen. Johnson, Jack , Rep. Lamberth, William

Summary: Provides annual \$600 payments to volunteer firefighters who complete an in-service training course of at least 40 hours duration and appropriate to their rank, responsibility and the size and location of their department. Defines "volunteer firefighter" as an unpaid member of a fire department that is recognized by the state fire marshal and is required to extinguish and control fires. Part of Administration Package.

Amendment Summary: Senate amendment 1 (004347) adds language specifying that a person is only eligible for payment as a firefighter or a volunteer firefighter, whichever is greater. Rewrites the definition of "firefighter" to specify that the person must be employed at a fire department that is registered and recognized by the state fire marshal and removes language that the person's primary livelihood must come from this work.

Fiscal Note: (Dated March 10, 2021) Increase State Expenditures - \$3,825,600/FY21-22 and Subsequent Years The Governors proposed budget for FY21-22, on page A-35, recognizes a recurring increase in state expenditures to the General Fund in the amount of \$4,922,000.

Senate Status: 04/28/21 - Senate passed with amendment 1 (004347).

House Status: 05/03/21 - House passed.

Executive Status: 05/21/21 - Enacted as Public Chapter 0478 effective May 18, 2021.

**SB841/HB511 CRIMINAL LAW: Punishment for first-degree murder.**

Sponsors: Sen. Johnson, Jack , Rep. Gant, Ron

Summary: Limits the punishment a jury can consider for a defendant convicted of first-degree murder committed against law enforcement officers, correctional officers, or rescue workers engaged in the performance of their official duties to death or imprisonment for life without possibility of parole.

Amendment Summary: House amendment 2 (004394) rewrites this bill to change present law concerning the Class A felony offense of commission of an act of terrorism. This amendment makes the killing of another in the perpetration or attempted perpetration of the commission of an act of terrorism an offense for which a person may be convicted of first degree murder without the state being required to prove that the person had a culpable mental state other than the intent to commit an act of terrorism. This amendment removes imprisonment for life as a sentencing option for such offense, so that a person convicted of such offense must be sentenced to death or life imprisonment without possibility of parole. This amendment expands the type of acts that constitute an act of terrorism to include an act that is intended, directly or indirectly, to serve as a premeditated, politically motivated act of violence, or violence in pursuit of religious, ideological, or social objectives, perpetrated against first responders, including law enforcement officers, correctional officers, department of correction employees, probation or parole officers, paramedics, firefighters, or other emergency medical rescue workers acting in their official capacity, which results in loss of life. This bill requires that any such act of terrorism is prosecuted and sentenced as first degree murder. House amendment 1 (003894) changes the jury instruction for the sentence of imprisonment for life in first degree murder cases to inform the jury that a defendant who receives a sentence of imprisonment for life is not eligible for parole consideration until the defendant has served at least 51 (rather than 25) full calendar years of the sentence. Senate amendment 2 (007625) deletes all language after the enacting clause. Expands the meaning of an act of terrorism to include an act or acts intended, directly or indirectly, to serve as a premeditated, politically motivated act of violence, or violence in pursuit of religious, ideological, or social objectives, perpetrated against first responders, including law enforcement officers, correctional officers, department of correction employees, probation or parole officers, paramedics, firefighters, or other emergency medical rescue workers acting in their official capacity, which results in loss of life. Requires such acts of terrorism to be prosecuted as first-degree murder offenses and sentenced as death or imprisonment for life without the possibility of parole. Outlines jury considerations for imposing such sentences.

Fiscal Note: (Dated February 5, 2021) NOT SIGNIFICANT

**SB842/HB512 CRIMINAL LAW: Sentencing of attempted first degree murder.**

Sponsors: Sen. Johnson, Jack , Rep. Gant, Ron

Summary: Allows a person convicted of attempted first degree murder to be sentenced to imprisonment for life without possibility of parole if the offense is committed against any law enforcement officer, correctional officer, department of correction employee, probation and parole officer, emergency medical or rescue worker, emergency medical technician, paramedic, or firefighter who was engaged in the performance of official duties.

Amendment Summary: House amendment 1 (004322) clarifies that this bill applies to the persons listed above who were engaged in the performance of official duties.

Fiscal Note: (Dated February 5, 2021) NOT SIGNIFICANT

House Status: 03/25/21 - House passed with amendment 1 (004322).

Executive Status: 05/13/21 - Enacted as Public Chapter 0394 effective July 1, 2021.

**SB912/HB1153 PUBLIC FINANCE: Appropriations for the fiscal years beginning July 1, 2020, and July 1, 2021.**

Sponsors: Sen. Johnson, Jack , Rep. Lamberth, William

Summary: Makes appropriations for the fiscal years beginning July 1, 2020, and July 1, 2021.

Amendment Summary: House amendment 11 (007995) changes funding for statewide chancery court in Section 64, Item 11 from \$1,094,000 (recurring) to \$2,000,000 (recurring).

Senate Status: 04/29/21 - Senate concurred in House amendment 11 (007995).

House Status: 04/29/21 - House passed with amendment 11 (007995).

Executive Status: 05/18/21 - Enacted as Public Chapter 0454 effective July 1, 2021 (108 pages).

**SB1023/HB1356 LOCAL GOVERNMENT: James 'Dustin' Samples Act.**

Sponsors: Sen. Briggs, Richard , Rep. Ramsey, Bob

Summary: Enacts the "James 'Dustin' Samples Act," which establishes that if a firefighter is diagnosed with post-traumatic stress disorder within three years of the firefighter's final date of employment with the fire department then it is presumed to be an injury incurred in the line of duty and is eligible for compensation under the Worker's Compensation Law. Exempts conditions clearly caused solely by a non-service-connected exposure, disciplinary action, termination, or demotion.

Fiscal Note: (Dated March 25, 2021) Increase Local Expenditures Exceeds \$4,680,000/FY21-22 and Subsequent Years\*

Senate Status: 05/04/21 - Senate Finance, Ways & Means Committee deferred to first calendar of 2022.

House Status: 05/03/21 - Taken off notice in House Finance, Ways & Means Subcommittee.

**SB1111/HB965 RETAIL TRADE: Grace period for expiration of firework permits.**

Sponsors: Sen. Niceley, Frank , Rep. Bricken, Rush

Summary: Extends, from two days to three days, the grace period for expiration of firework permits.

Amendment Summary: Senate amendment 2 (007152) deletes and rewrites all language after the enacting clause such that the substantive change is requiring an applicant for a fireworks manufacturer, distributor, wholesaler, annual retailer, or seasonal retailer permit to be locally licensed to do business in this state and registered with the Department of Revenue (DOR). Effective October 1, 2021.

Fiscal Note: (Dated February 23, 2021) NOT SIGNIFICANT

Senate Status: 05/03/21 - Senate passed with amendment 2 (007152).

House Status: 05/03/21 - House passed.

Executive Status: 05/21/21 - Enacted as Public Chapter 0485 effective October 1, 2021.

**SB1138/HB585 CRIMINAL LAW: Harassment of a first responder.**

Sponsors: Sen. White, Dawn , Rep. Terry, Bryan

*Summary:* Increases the penalty for harassment if the person committed the offense because of the victim's actual or perceived employment as a first responder. Defines "first responder" for the purposes of harassment to mean a correctional officer employed by the department of corrections, an emergency medical technician, a firefighter, a law enforcement officer, or any other person who responds to calls for emergency assistance. Broadly captioned.

*Fiscal Note:* (Dated February 24, 2021) Increase State Expenditures \$458,500 Incarceration\* Decrease Local Expenditures \$37,300/FY21-22 and Subsequent Years

*Senate Status:* 04/20/21 - Failed in Senate Judiciary Committee.

*House Status:* 05/03/21 - Taken off notice in House Finance, Ways & Means Subcommittee.

**SB1251/HB1483 GOVERNMENT ORGANIZATION: Attendance requirements for members of the commission on firefighting personnel standards and education.**

*Sponsors:* Sen. Reeves, Shane , Rep. Littleton, Mary

*Summary:* Mandates that members of the commission on firefighting personnel standards and education who miss more than 50 percent of the scheduled meetings in a calendar year must be removed as a member. Broadly captioned.

*Fiscal Note:* (Dated March 2, 2021) NOT SIGNIFICANT

*Senate Status:* 04/13/21 - Taken off notice in Senate State & Local Government Committee.

*House Status:* 04/06/21 - House Cities & Counties Subcommittee deferred to first calendar of 2022.

**SB1314/HB1450 LOCAL GOVERNMENT: Imposing of a public safety surcharge.**

*Sponsors:* Sen. Hensley, Joey , Rep. Doggett, Clay

*Summary:* Allows municipalities, counties and metro governments to impose a public safety surcharge for providing public safety services upon the adoption of a resolution in the entity's legislative body. Requires that funds generated by the surcharge be separated from the general fund and used to fund public safety services. Establishes regulations for adopting and changing the surcharge.

*Fiscal Note:* (Dated April 3, 2021) Increase Local Revenue Exceeds \$100,000/FY21-22 and Subsequent Years

*Senate Status:* 04/13/21 - Taken off notice in Senate State & Local Government Committee.

*House Status:* 04/06/21 - House Cities & Counties Subcommittee deferred to first calendar of 2022.

**SB1569/HB335 PUBLIC EMPLOYEES: Compensation paid to firefighters for certain conditions or injuries.**

*Sponsors:* Sen. Bailey, Paul , Rep. Hicks, Gary

*Summary:* Increases, from 10 working days to 12 working days, the time within which, after receipt of a written appeal, the state fire marshal's office must provide a decision in cases of conflict between a city and county regarding a building or fire code issue. Broadly captioned.
